Worth County High School Stands Out For Sportsmanship

Worth County High School was recently presented the 2014 Georgia High School Association Cooperative Spirit Sportsmanship Award.

Worth County High School was recently presented the 2014 Georgia High School Association Cooperative Spirit Sportsmanship Award.

Through a partnership of the Georgia High School Association and the state's 41 electric cooperatives, including Mitchell EMC, the award is presented annually to deserving high schools to underscore the importance of sportsmanlike qualities in student athletes, administrators, educators and event spectators. "We're pleased to recognize and honor schools that value, expect, and demand good sportsmanship from their athletes," says Tony Tucker, President and CEO with Mitchell EMC.

"We want to support efforts that help shape the moral, ethical, and spiritual character of young adults." Since its introduction in 2006, the Sportsmanship Award has grown in prestige and importance, particularly since school officials, teachers and coaches agree that a lack of sportsmanship can be an indicator of potential character issues and troubling personality traits.

For this reason Georgia high schools have placed an increased emphasis on a student's ability to demonstrate sportsmanlike qualities. Some are implementing zero tolerance policies which prohibit profanity, degrading remarks and intimidation during competition.

Since the Award recognizes not only student athletes but fellow students, school staff, parents and event spectators, it has become not only a school honor, but a community honor as well. The winners are selected by the GHSA region secretaries based upon suitable behavior throughout the school year. Worth County High is one of 48 GHSA-member high schools around the state (from 48 regions in six

classifications) that received the award for exhibiting exceptional sportsmanship.

The GHSA is a voluntary organization comprised of more than 400 public and private high schools that strives to promote good sportsmanship and a cooperative spirit among its member schools.

Capital Credit Retirement

As a Member of Mitchell Electric Membership Corporation, you are also an owner. Each year, revenues remaining after expenses, are allocated to you in the form of Patronage Capital. Patronage Capital represents equity or working capital, and is your ownership interest in the cooperative. These funds are utilized for a period of time to insure the financial stability of the cooperative and then returned to you in the form of a patronage refund. These funds are used in place of borrowed capital as a source of funding for distribution facilities and general utility plant expenses. This allows the cooperative to borrow less money and thus incur lower interest charges. By reducing interest expenses this way, Mitchell EMC saves money for its members.

The Board of Directors of Mitchell EMC is pleased to announce the refund of Patronage Capital for all years prior to and including 1983. If you were a member of Mitchell EMC during these years, you are eligible to receive a refund for the patronage allocated to your account as of December 31, 1983. A complete listing of all accounts entitled to a Patronage Capital refund can be found online at www.mitchellemc.com or at any Mitchell EMC office. The retirement of Patronage is just one of the unique benefits of being a member of Mitchell Electric Membership Corporation.

Estate refunds are also considered yearly and are distributed several times each year. Contact our office to request an estate refund. Once an estate refund distribution has been issued, all funds due this account are returned.

Georgia Agricultural Tax Exemption Expires Dec. 31

If you're an agricultural producer and receive the Georgia Agricultural Tax Exemption (GATE) on electricity, you must renew it beginning this October.

GATE is an agricultural sales and use tax exemption certificate issued by the Georgia Department of Agriculture. The document identifies its user as a qualified farmer or producer who is exempt from sales tax on the inputs used in the production of their commodity.

Mitchell EMC member-owners who receive a GATE certificate should send us a copy along with the account numbers that apply to the GATE certificate, so we can apply the exemption to their account. **We must receive a copy of the new certificate by December 31 for the exemption to continue. If a new Tax exempt account needs to be added, then you will need to submit a new Addendum Form with those new accounts and meter numbers.**

Producers who have never received GATE can also apply and send a certificate copy to Mitchell EMC. Visit <https://forms.agr.georgia.gov/gate/> or call 855-FARM TAX for more information, to renew or apply.

Honeybun Cake

1 package Duncan Hines Yellow Cake Mix
(without pudding)
8 ounces sour cream
 $\frac{3}{4}$ cup of Crisco oil
4 eggs

Mix well.

*In another
bowl mix:*

1 cup light
brown sugar
1 tablespoon
cinnamon
1 cup
chopped
pecans



Topping:

1 cup confectioners' sugar
2 to 3 tablespoons water

Pour $\frac{1}{2}$ of cake batter in a greased 9X13 in pan. Sprinkle all of sugar, cinnamon, and pecan mixture over this layer. Add remainder of batter mixture to pan. Bake as directed on cake package. Mix 1 cup confectioners' sugar with 2 or 3 tablespoons of water. Spread this over hot cake when removed from the oven. Let cool and enjoy.
