Mitchell EMC Right-of-Way Program

The Right of Way maintenance program at Mitchell EMC strikes a delicate balance in keeping the property beneath the power lines free from hazards while simultaneously keeping you as well as cooperative employees safe from potential dangers. Mitchell EMC maintains a 30 foot right of way easement—15 feet on each side of its power lines.

“Right of Way” refers to the strip of land owned by another party on which utilities place their facilities. The utilities have access to this land, and they are responsible for the maintenance of the area to ensure the facilities are clear from vegetation and obstructions.

Right of way crews work year-round according to a detailed 5 year rotation cycle to keep more than 5,500 miles of ROW clear for its power lines. Where it is apparent the property owners are actively maintaining the right of way and nothing is planted on or close by that could interfere with the power lines, ROW crews will move to the next property where clearing is needed. And, when ROW needs clearing, underbrush is cut, and trees growing too near the power lines are trimmed or in some cases potentially removed. Exposed stumps are treated to prevent sprouting.

Fortunately many Mitchell EMC member-owners are cooperative when crews arrive to maintain the property within the right of way. A well maintained ROW directly benefits the property owner and it may also potentially benefit others nearby. Did you know your untrimmed trees could cause power outages for your neighbors too? A clear

ROW reduces costly repairs to the power distribution system and considerably improves service reliability. Members tell us one of the most noticeable changes they see as a result of ROW maintenance is the absence of those annoying blinks on their digital clocks and electronics.



Overhead power lines are not the only concern. A clear space is also needed around underground transformers. When underground wiring needs repair, line technicians will need open access to those large green boxes (a.k.a. pad-mount transformers). These transformers carry several thousand volts of electricity. Even small additions of shrubs and flowers planted too close to the transformer can be hazardous and may interfere with power delivery. At least 10 feet of clear unobstructed space on all sides of the transformer should be maintained. An underground transformer indicates underground service and power lines are buried from the transformer to your home. For your personal safety never dig anywhere in your yard without first calling 811 to find out where the buried lines are located.

At Mitchell EMC safety and power delivery go hand in hand. Remember, both line and right of way crews working under or around Mitchell EMC power lines and transformers typically drive trucks identified with the cooperative's logo. If you have questions about someone working near energized lines, underground transformers, etc., please telephone Mitchell EMC.



Roasted Summer Squash

Ingredients

yellow squash or zucchini, desired amount
½ tsp garlic flakes or garlic powder
salt to taste
black pepper
1 tablespoon of olive oil
½ cup parmesan cheese

Directions

Cut the squash into ¼ in. slices and cut each slice into half-moons. Coat squash in oil. Add seasonings. Place squash on cookie sheet. Place on lower rack in a 400 degree oven. Bake for 12 minutes. Remove and coat with cheese. Return to oven and let bake for 3 minutes or until cheese is melted. This is an easy and delicious way to enjoy summer squash.
