Mitchell EMC Offers Students Lessons in Leadership and Civic Responsibility

Leadership is not about titles, positions or flowcharts. It is about one life influencing another. –John C. Maxwell

Outstanding students from across Georgia, including Luke Cooper, Worth County High School; Landon Davidson, Sherwood Christian Academy; Mychael Hall, Deerfield Windsor School; Slater Stringer, Westwood School, recently returned from the Washington Youth Tour, a week-long leadership experience exclusively for teens sponsored by the electric cooperatives in Georgia, including Mitchell EMC.

From June 13-20, they joined 1,800 of their accomplished and ambitious peers in Washington, D.C. to understand the importance of civic engagement, to tour national historic sites and to learn valuable leadership lessons they can utilize in their communities back home. The lessons learned by students cannot be replicated in the classroom.

Heather Greene with Mitchell EMC believes that this carefully chaperoned tour of the nation's capital, full of our national treasures, provides not only an opportunity for an enriched history lesson but also a unique experience that includes interactive exhibits and firsthand accounts.



In Georgia, this year's contingent included 115 student delegates, 13 chaperones and three tour directors who attended a kick-off banquet in Atlanta for the student delegates and their families before departing the next morning for D.C. for the remainder of the trip.

"The students watch history come to life as they walk and talk in the same places where people have helped shape our country," says Greene with Mitchell EMC.

"They also meet other delegates from across the country with different backgrounds, life experiences and walks of life to give them a broader perspective and deeper appreciation of the world at large."

With a firm commitment to enriching our future, the purpose of the Youth Tour is to help EMCs develop our state's most precious resource, our youth, according to Greene.

While in D.C., stops included Mount Vernon, Arlington Cemetery, U.S. Capitol, National Archives, National Cathedral, and the Smithsonian Museums. The students also toured the revered Jefferson, Lincoln, FDR, MLK, WWII, Vietnam and Korean War memorials. In addition, the group had dinner one evening at Toby's Dinner Theater and saw the play "Grease".

In addition to taking in the sights of the nation's capital, students gained perspective on some of today's important issues and their role as involved citizens. Everyone had the opportunity to engage with staff and/ or members of Georgia's congressional delegation as well as a visit with U.S. Secretary of Agriculture Sonny Perdue.

Finally, all state groups convened for All-States Youth Day, sponsored by the National Rural Electric Cooperative Association, to learn from public figures and other inspirational speakers. The Georgia delegation met with a number of congressional leaders. Nearly 50,000 students from rural areas and small towns across America have participated in this program. Some



Youth Tour alumni have gone on to design airplanes, to lead companies and to serve in the highest ranks of government, including the U.S. Senate, and many more are serving in some role in state and local government.

Georgia Agricultural Tax Exemption Expires Dec. 31

If you're an agricultural producer and receive the Georgia Agricultural Tax Exemption (GATE) on electricity, you must renew it beginning this October.

GATE is an agricultural sales and use tax exemption certificate issued by the Georgia Department of Agriculture. The document identifies its user as a qualified farmer or producer who is exempt from sales tax on the inputs used in the production of their commodity.

Mitchell EMC member-owners who receive a GATE certificate should send us a copy along with the account numbers that apply to the GATE certificate, so we can apply the exemption to their account. *We must receive a copy of the new certificate by December 31 for the exemption to continue.*

September Final Month to Claim Undeliverable Patronage Capital

Members can review a list of unclaimed patronage capital due to be escheated online or in one of our district offices.

The last possible date to claim these funds is on September 27, 2019. If these funds are not claimed by this date, they will be donated for charitable uses, as permitted by O.C.G.A 44-12-236.

Our headquarters office located in Camilla and district offices located in Albany and Sylvester have hardcopy list available for review. Our offices are open Monday-Friday, 8 a.m. to 5 p.m. Members can also access this list at www.mitchellemc.com, then About Us - Patronage Capital – Patronage Capital Escheatment.

Margin Assignment for 2018

Margins accrued by Mitchell EMC (revenue after all expenses have been paid) have been assigned to Member's patronage credit records. This assignment is made by applying the percentage of the Cooperative's margins to each Members' annual bill, before taxes. The percentage from Mitchell's margins for 2018 is 1.47%.

The table below shows examples of how you may figure your assignment. Simply multiply the percentage figures shown below times your total billing, less sales taxes, for the year.

Attention Farmers Just a reminder...

Time Of Use (TOU) rates for irrigation systems began on June 1. The TOU kWh cost is based on the time of day in which it is used. The rate will distinguish between ON-PEAK and OFF-PEAK usage. *TOU rates apply from June 1 through September 30. If you have any questions, please do not hesitate to contact us at 229-336-5221 or 1-800-479-6034.

<u>Note:</u> If you move or no longer have electric service with Mitchell EMC, it is important that members keep their address current, so that future disbursements can be properly mailed. Capital credits are reserved for members even if they move out of the Mitchell EMC service area. Mitchell EMC will make a diligent effort to send a check by mail.
