# PELHAM HIGH SCHOOL STUDENT ADVANCES TO STATE WIRING COMPETITION

unter Coker of Pelham, who is a member of Pelham High School's FFA chapter, recently came in second in the Area 5 Electrification Career Development Event (CDE) Competition. Hunter will advance to the State CDE competition in January.

"This CDE allowed me the opportunity to learn about wiring and the electrical code, and to be able to practice in a safe environment. The knowledge and skills will be beneficial to me in the future," says one recent student participant.

"We're very proud of Hunter's accomplishment. The electrification CDE is a tough competition," says Nathan Ireland with Mitchell EMC.

Each participant completes a practical wiring problem testing their knowledge of the National

Electric Code, a multiple choice written exam, and gives an oral presentation describing necessary steps to complete a specific electrical task.

For more than 50 years, this unique educational activity has partnered FFA chapters with their local electric membership cooperative (EMC) to teach electrical wiring and interpersonal skills. Mitchell EMC employees mentor FFA students to prepare them for the contest, hold local practice

sessions and staff the area and state contests.

"We believe that this EMC/FFA Electrification CDE is an opportunity to expand a student's knowledge, and maybe even help him determine a career path, says Nathan Ireland with Mitchell EMC.

The contest reinforces electrical wiring as taught in the vocational agriculture education program and expands the student's grasp of electric energy and the role of EMCs in Georgia's energy future. Any active FFA member who is in grade 10, 11, or 12 in the state of Georgia is eligible to participate and compete

for scholarship funds to use at any college, university or vocational school in Georgia.

By offering scholarships to area and state winners, EMCs across Georgia give youth added incentive to participate in the CDE. And the benefits don't stop when the contest ends. Their participation can play a huge role in propelling students forward into the future. Students develop a passion for wiring through CDE which inspires them to pursue degree programs and industry certifications in the electric and agriculture fields. Some have graduated with engineering degrees, while others have gone on to become agriculture teachers in local high schools, colleges and universities.

Mitchell EMC is consumer-owned cooperative providing electricity and related services to 15,379

members in Baker, Dougherty, Mitchell and Worth Counties, and in parts of Calhoun, Colquitt, Decatur, Early, Grady, Lee, Miller, Thomas, Tift and Turner counties.

# Georgia Agricultural Tax Exemption Expires December 31

If you're an agricultural producer and receive the Georgia Agricultural Tax Exemption (GATE) on electricity, you must renew it beginning this October.

GATE is an agricultural sales and use tax exemption certificate issued by the Georgia Department of Agriculture. The document identifies its user as a qualified farmer or producer who is exempt from sales tax on the inputs used in the production of their commodity.


Mitchell EMC member-owners who receive a GATE certificate should send us a copy along with the account numbers that apply to the GATE certificate, so we can apply the exemption to their account. We must receive a copy of the new certificate by December 31 for the exemption to continue.

# Downed and Dangerous


If you see a downed power line, always assume it is energized and dangerous. Avoid going near it or anything in contact with the power line.



Downed power lines can energize the ground up to **35** ft. away – so keep your distance.



Never drive over a downed line or through water that is touching the line.



If you see a downed line, notify the local authorities immediately.



Never try to move a downed power line, even if you think the line is deenergized or if you're using a non-conductive item – this will not prevent injury or death!

# Mitchell EMC Facilities Charge Adjustment

Currently, some of the fixed costs of servicing your account are recovered through what you pay for electricity. We are moving to more accurately allocate these costs, both fixed and energy, to their true sources. Effective with member billings that begin on January 1, Mitchell EMC's Facilities Charge will increase by \$3.00 per month.

The Facilities Charge partially covers the fixed costs of delivering your electric service. These fixed costs include reading your meter; maintaining the electric distribution system used in keeping your power flowing; maintaining rights of way; and performing other tasks necessary to ensure a reliable electric distribution system. The Facilities Charge **does not** include the cost of the actual electricity you use. The monthly Facilities Charge is changing because the costs of servicing your account are rising. Every member benefits from these services, so the monthly Facilities Charge helps Mitchell EMC ensure that the cost are spread fairly among our membership.

We continue to offer free in home energy audits to help Members with options to make their homes more energy efficient. Our energy efficiency program includes rebates whether you are building a home, or just upgrading your present home. 

### **Christmas Greens**
