One Year Later...

The one year anniversary of Hurricane Michael is here. Hurricane Michael ripped through our service territory and caused massive devastation. Michael was the first Category 5 hurricane to strike the United States since Andrew in 1992. It was the first Category 5 hurricane on record to impact the Florida Panhandle.

Every consumer on Mitchell EMC's lines felt the destruction of Hurricane Michael. With 100% of our system down, we had work to do. Forty cooperatives from 6 states and 6 contract companies came to our aid. Over 675 linemen and right of way crew members worked day and night to restore power to our consumers. Customer Service Representatives answered over 40,000 phone calls in 16 days. Dispatchers worked to make sure crews were safe and sent to locations where they were needed and logged outages. It took the entire team



to get the job done.

Not only did the cooperatives and contract crews come to our aid, but our communities we serve showed their love and support for us. Countless numbers of volunteers came and worked from sun up to sun down as well. They fed us, washed clothes, put snacks together, wrote words of encouragement, and showed their love and support daily. Not to mention the highlight of the days...homemade pecan pies! If we needed it, they found a way to get it. We will never be able to thank you enough for your generosity and support.

Work is still being done to restore damaged caused by Hurricane Michael. If you still have any storm related debris in your area, please give Mitchell EMC a call and report it. Georgia Agricultural Tax Exemption Expires December 31

If you're an agricultural producer and receive the Georgia Agricultural Tax Exemption (GATE) on electricity, you must renew it beginning this October.

GATE is an agricultural sales and use tax exemption certificate issued by the Georgia Department of Agriculture.



The document identifies its user as a qualified farmer or producer who is exempt from sales tax on the inputs used in the production of their commodity.

Mitchell EMC member-owners who receive a GATE certificate should send us a copy along with the account numbers that apply to the GATE certificate, so we can apply the exemption to their account. *We must receive a copy of the new certificate by December 31 for the exemption to continue.*

<u>Note:</u> If you move or no longer have electric service with Mitchell EMC, it is important that members keep their address current, so that future disbursements can be properly mailed. Capital credits are reserved for members even if they move out of the Mitchell EMC service area. Mitchell EMC will make a diligent effort to send a check by mail.

Turtle Pumpkin Pie

Ingredients:

 honey maid graham pie crust
cup plus 2 tablespoons of chopped pecans (divided)

1 cup cold milk

2 pkgs (3.4 oz ea.) vanilla pudding mix

1 cup canned pumpkin

1 teaspoon of ground nutmeg

1 teaspoon of ground cinnamon

1 8oz cool whip (divided)

¹/₄ cup plus 2 tablespoon of caramel ice cream topping (divided)

Directions:

Pour ¼ cup caramel topping into pie crust, sprinkle with ½ cup of nuts. Beat pudding mixes, milk, pumpkin and spices until blended. Stir in 1 ½ cups of cool whip into mixture. Spoon mixture into pie crust. Refrigerate for one hour. After an hour top pie with remaining cool whip, caramel topping and nuts.
